OFFICIAL RULES

- PROMOTION DESCRIPTION. The Kellogg's[™] MLB[®] All-Star Game Experience in Cincinnati Text-to-Win Game (the "Game") is a Text and Online Instant Win Game that begins on 4/27/15 at 12:00:00 PM Eastern Time ("ET") and ends on 6/7/15 at 11:59:59 AM (ET) (the "Promotion Period"). Look on specially marked point-of-sale ("POS") material at participating retailers for the Short Code and keyword; and then follow the instructions provided to play the Game via text or online – as more fully described below. Game plays must be completed by 6/7/15 at 11:59:59 AM (ET). To enter for free, see the Online play method below in rule #3b.
- 2. ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older (except in the case of legal residents of certain states where the legal age of majority is greater than eighteen (18) years of age, such legal age of majority) at time of entry.
